- The District guarantees neither the quantity nor quality of water to be pumped nor makes any representation whatsoever as to the permanence of the water flows or water courses, as they exist.
- 2. All water, other than that delivered by the Ditchrider, which is taken from a canal, lateral, or drain (open or closed), by pumping or any other method of diversion, shall have a permit issued annually by the District.
- 3. This permit will allow a 2hp pump or smaller and maximum 1 ½ inch pipe inlet. All pumps having a suction line greater than 1-1/2 inches in diameter or pumping more than 50 gallons per minute shall install a flow meter that measures instantaneous flow in cubic feet per second and totals in acre-feet District Ditch Rider confirmation.
- 4. It shall be the responsibility of the permit holder to maintain proper weed control surrounding the pump installation so as to provide a clear and unobstructed view of the installation.
- 5. The permit holder will be responsible for installation, removal, maintenance, liability and damage. In the event the pump or related equipment becomes damaged during maintenance of the ditch, permit holder shall hold harmless the irrigation district and its employees from all charges stemming from such damage.
- 6. Any pump not displaying a current year tag may be confiscated by the District or State Engineers Office. Confiscated pumps will be returned to the rightful owners upon purchase of a current year permit. Reinstallation shall be at the expense of the permit holder.

The Heart Mountain Irrigation District reserves the right to regulate or revoke the rights granted by this permit at any time. This permit shall not constitute the granting of a permanent right to pump or utilize said water.
